Legal meanings

These are some words you might need to know when writing your Will.

Beneficiary: A person or organisation who receives something from your estate.

Bequest: A gift in your Will. There are three main types of gifts - residuary (a share of your estate), pecuniary (a specific sum of money) or specific (a particular item).

Codicil: An addition or change to an existing Will.

Estate: The total value of everything you own at the time of your death, less any outstanding debts.

Executors: A person or persons you appoint to make sure that the wishes in your Will are carried out. They could be a trusted friend or family member or a professional such as your solicitor. Whoever you chose, make sure that you ask for their permission first.

Guardians: A person or persons you would like to look after children who, in the event of your death, have not yet reached adulthood. Discuss your wishes with the people you wish to appoint to make sure that they agree.

Intestacy: The name for the situation that happens when someone dies without making a Will. An Administrator will be chosen by law to settle your affairs if you die without making a Will.

Probate: The legal process that establishes if your Will is valid.

Testator (male) Testatrix (female): The person making the Will.
